I am directed to convey the Administrative Sanction to hold the National Coaching Camp of Canoe Sprint for Junior Men & Women 21 Campers, comprising of 04 Canoe Men + 04 Kayak Men + 04 Canoe Women + 05 Kayak Women + 04 Coaches with effect from 18th August to 25th September, 2016 (39 Days) at SAI, CRC, Bhopal in preparation of 01st Asian Canoe Sprint Cup to be held at Samarqand, Uzbekistan from 28th September to 03rd October, 2016.

The Terms & Conditions for the Camp will be as under:-

1. Boarding Charges @ Rs.450/head/day for 21 campers for 39 days.
2. Nutritional Supplements @ Rs.300/head/day (For paddlers only).
3. Lodging Charges @ Rs.1200/day/person for 21 Campers (Rs.900 to be booked to SAI (HQ) and Rs.300 as Overhead Charges).
4. Petrol Charges upto Rs.1000/day on water training days for Coach Boat & Rescue Motor Boat.
5. Hiring of Bus from SAI, Center, Bhopal to Lake twice a day to & fro – As per actual
6. TA/DA, By Train 'II AC' only.
7. List of Players, Coaches and Supporting Staff enclosed.
8. Please ensure that the guidelines issued by TEAMS Division for holding of National Coaching Camp is adhered to.
9. List of Campers (Sports persons, Coaches and other Supporting Staff) reported for the camp should be forwarded to the TEAMS Division after 3rd day from the commencement date of the Camp.
10. Any inclusion/ deletion of National Campers should not be entertained without prior approval of the TEAMS Division.
11. Medical on actual basis.
12. On conclusion of the National Coaching Camp, National Coach/Coach Incharge shall submit a report on Coaching Camp through the Director of the concerned Regional Centre within 10 days to the ED (TEAMS). The Director I/C concerned shall also submit the expenditure statement for the camp within a month to the ED (F) with a copy to the TEAMS Division.
13. The expenditure will be debited under the Head "General Assistance for Holding Coaching Camp (Code No.840000).
14. All bills pertaining to the Camp shall be settled within 21 days of completion of the camp.
15. All the equipments (consumables and non-consumables) issued for the camp has to be entered in the stock and issue register and shall be returned to the camp Incharge on completion of the camp.
16. Attendance of all the campers is to be maintained and monitored on daily basis.
17. All age category camps will commence only after age of players has been verified as per the Age Certification test approved by the MYAS. Players who fall within the age range of the camp be permitted to attend.


