- 2. The e nomination of a candidate for election as Office Bearer or a Member of Executive Committee shall be proposed by one of the representative of member of State/Union Territories whose name is included in the electoral college list in form-1 and also subscribed by 1(one) such representatives as seconder.
- 3. Only members nominated by the State and Union Territory Association shall have voting rights. It will be mandatory for the members to give their PAN, ADHAR and participation in sports and games at the time of their Nomination.
- 4. No person shall be eligible to nominate more than one candidate for the same post, either as proposer or seconder and if he/she so does, his signature on the nomination paper delivered second in point of time to the Returning Officer shall be deemed to be inoperative.
- 5. No person shall be permitted to withdraw his/her name as proposer/seconder, once the nomination paper subscribed by him/her has been delivered to Returning officer.
